Postmasters are required to register letters and parcels whenever application is made, and a supply of blanks, envelopes, &c., for that purpose must be kept constantly on hand. For full instructions, see Title V, page 175, Postal Regulations, edition of 1879.

BOTH POSTAGE AND REGISTRY FEE MUST BE FULLY PREPAID BY ORDINARY STAMPS AFFIXED TO THE LETTER OR PARCEL—NOT TO THE REGISTERED-PACKAGE ENVELOPE—EXCEPT WHERE IT IS ON THE OFFICIAL BUSINESS OF ANOTHER DEPARTMENT, IN WHICH CASE THE REGISTRY FEE MAY BE PREPAID BY THE OFFICIAL STAMPS OF THAT DEPARTMENT.
