HOW CAN I MAKE MY GIFT TO UMPI?

As an employee, the easiest way to give is to use the form to sign up for payroll deductions or a one time gift of cash or check. You can also donate online, using a credit card, at umpi.edu/donate, or you can stop by the President's Office and see Debbie Roark to make your gift.

HOW WILL I BE RECOGNIZED FOR MY GIFT?

Employee donors who make their gift by the end of the Faculty and Staff Giving Campaign will be recognized during the all-employee celebration in March unless they request to remain anonymous. Employee donors who do not wish to remain anonymous may also be recognized during other events at various times of the year.
